CONTRACT FOR SERVICE

The receipt by the NASW-AZ of your signed contract, accompanied by payment for the full amount, will constitute a contract for the right to use the space allocated. In the event of fire, strikes or other uncontrollable circumstances, NASW-AZ shall have no liability or obligation and will make every effort to refund such portion of the exhibit fees not expended or encumbered. Applications must be on the official form or online and accompanied by a payment for the full amount in order to be honored.

EXHIBIT RESTRICTIONS

Exhibits must conform to the size of their assigned space and must not obstruct the view or interfere with other exhibits. All demonstrations, discussions, or other activities, such as the distribution of descriptive literature of any kind, must be confined to the exhibitor's own booth. Sales, order-taking and solicitation of sales orders on the floor of the exhibit area or within other facilities leased by NASW-AZ are prohibited. No exhibitor shall assign, sublet, or share the whole. Displays should not be placed on such a manner as to interfere with or be objectionable to other exhibitors.

PROTECTION OF THE FRANCISCAN RE-NEWAL CENTER

The exhibitor assumes the entire responsibility and liability for losses, damages and claims arising out of injury or damage to exhibitor's displays, equipment and other property brought upon the premises of the Franciscan Renewal Center. Exhibitor shall indemnify and hold harmless Franciscan Renewal Center, agents, servants, and employees from any and all such losses, damages and claims.

In addition, exhibitor acknowledges that NASW-AZ and the Franciscan Renewal Center do not maintain insurance covering exhibitor's property damage. Insurance covering such losses is the responsibility of exhibitor.

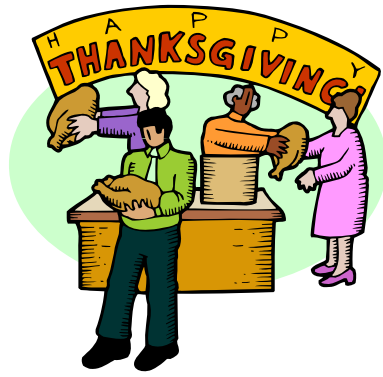
